- CSMA. The Civil Service Motoring Association, is a membership of just over 280,000 members. They cover the whole of the Civil and Public Service, including teachers, and this fills in the gaps between DDS and BLC for us. Card members are issued with a 'Boundless by CSMA' Card
- BLC (Blue Light Card). A card membership programme run by BLC Ltd, offering discounts to serving Police Officers, Paramedics, Fire Fighters, and NHS medical staff.
- Membership is growing at around 150 new members a week, with BLC promoting the programme through advertising within Blue Light Sports & Social Clubs and events.
- **DDS (Defence Discount Service).** The MOD's own brand for discounted savings on all sorts or branded items, from major retailers
- Designed by the MOD to bring a level of savings for those who are serving in the military, as well as reservists and veterans, as a way of saying 'thank you' for their time of service.
- Membership is growing at around 1000 new members a week, mainly on the back of the MOD pushing the programme through JPA payslips, reservists centres and UK base representation.



PROGRAMME SALES PROCESS

DDS / BLUE LIGHT / CSMA CARD PROGRAMME





- Identify if the customer has a DDS, Blue Light or Boundless Card
- If they do not have a card but are eligible then contact Griffin on 01273 574000 who will help you obtain one.
- Quote the customer in the normal way using our support as outlined

Take a copy of the customers photo i.d. and DDS, Blue Light, or CSMA Card and send, together with a copy of the order form and data protection form (last page of this guide), and email to Renault@Griffintaxfree.com.

A tracking number will then be issued by Griffin. Please keep this with your order file

Order the car/van using **FON 70033**, sales channel 5B for local fleet making sure that Griffin's details are overtyped with the registered keepers information.

From time to time Griffin may contact you with a lead or confirmed order. If the order is confirmed the proofs will have already been obtained and you can order the car as above. Griffin do not take a commission from you for this service.

- Please ask the customer to sign the Data Protection notice should they be concerned about GDPR, and also send this to Griffin. This is not compulsory as we will not pass on the customers details.
